Customer Responsibilities

The customer is responsible for completing the key fields on the Additional Accounts Information Form.

- 1. Company Name This section identifies the company requesting the MID(s) or PostalOne! Online Access. This information is used for administrative purposes only.
- **2. Date** Enter the date of the request.
- 3. Supporting Request for: If the document will be used for requesting access to PostalOne! and or adding additional permits or publications to an existing PostalOne! account then select PostalOne! Online Access. If requesting verification of mailer volumes select MID Request. If you are applying for PostalOne! access and a MID, please check both boxes. It is recommended that you apply for a MID when you are applying for PostalOne! Access.
- **4. Administrator's Printed Name and Signature** Printed Name and Signature of the Company Administrator as identified on the original Customer Request for WEB Access PS Form 1357-C.
- 5. Company Location: Company Name, Company Address, City, State and ZIP+4 Code –This section identifies a company's designated location. It may be a location where no mailings are performed or where no accounts are held with any Post Office or Business Mail Acceptance office. PostalOne! Online Access This is the location where all of your permits/publications will be assigned/grouped. This will allow users to view all permits/publications assigned to that location. MIDs-This is used for validation of mailing volumes at that location. Use multiple Additional Accounts Information Forms for different Company Locations.

6. List of Accounts

Permit # / Pub # / Finance # - PostalOne! Online Access - Enter each permit number or publication number you desire to connect to the Company Location. The finance number will be provided by the BMEU. **MIDs** – Enter the permit number or publication number you desire to have mailing volumes validated.

- Permit Type # Enter Permit Type (i.e. Additional Postage (AD), Permit Imprint (PI), Metered (MT), Precanceled (PC), OMAS Imprint (OI), OMAS Metered (OM), Periodical (PE), Periodical Pending (PP), Business Reply (BR), Postage Due (PD), Periodicals (PE), Ghost (GH).
- Company Name or Publication Name Enter the name of the Company on the Permit Account or the Name of the Publication.

- Address, City, State, ZIP+4 Code Enter the company's address that appears on the PostalOne! account record. The PostalOne!
 Account record must be updated with the current information if: 1) If the company's address is not current; 2) the company's address or mailing agent is not in the correct field. (See Account Management USPS Responsibilities)
- Post Office Information City, State, ZIP+4 Code (LOCATION WHERE THE PERMIT IS HELD) Enter the City State and ZIP+4 Code of the postal location where the permit / publication is held.

- 2. Approver Initials For PostalOne! Online Access The USPS Representative will be responsible for the validation and standardization of the company's name on all the accounts, verification of current addresses and verification of permits/publications are owned by the requesting company. MID Request The USPS Representative will be responsible for verifying mailer volumes.
- 3. USPS Rep. Print and Sign PostalOne! Online Access If the application was submitted to a USPS Representative (i.e. BSN, NAM etc) for account verification, the USPS Representative will print and sign their name. The USPS Representative will be responsible for the validation and standardization of the company's name on all accounts, verification of current addresses and verification of permits/publications are the owned by the requesting company. MID Request The USPS Account Representative will be responsible for verifying mailer volumes.
- **4. Account Management-** Ensure that the *PostalOne!* fields for Mail Owner and Mailing Agent are correctly entered (i.e. Company Information Address, contact information etc.)
