Dear NCOA Licensee:

Effective April 17, most of the NCOA<sup>Link®</sup> licensing fees will change. All new and existing licensees will be subject to the new fees, meaning any licenses, tests/audits, additional platforms or sites requested on or after April 17, must remit the new fees.

The Payment section in the NCOA<sup>Link</sup> License Agreement states the 'USPS shall have the right to modify any and all fees associated with this License Agreement after the end of the first one-year Term, and at the end of any or all subsequent one-year Terms, by informing Licensee of such price modification.'

You may note that there is a difference in the fee for first-year NCOA<sup>Link</sup> Limited Service Providers (LSP) (\$15,250) as opposed to the fee charged to renewing LSPs (\$15,500). We did not detect this inconsistency prior to Postal Service Board of Governors and Postal Regulatory Commission approval and finalization and are unable to correct until the next Rate Case. At such time, we will realign the two at the same price.
