ACTION ITEMS

 OT and transportation "changes." – Turned into all-encompassing discussion on performance and service impacts. Adam Collinson stopped the chat and asked if there is an MTAC Work Group that can address this and provide further discussion? Adam will take this suggestion to the EC.

- Delayed Mail USPS requested cases be sent to Steve and Josh
- o <u>During Leadership:</u> Rosser will write initial Task Team proposal
- Additional items from Chat for the Task Team:
 - Is forecast for Political Mail greater than the Holiday Peak?
 - Will increased package volume impact election mail?
 - Is election mail getting better service than other products with same postage rates?
 - Is there a plan to ensure that ballots are not delayed?
 - Impact on remittance mail? We had one plant tell us to expect delays because of the changes.
 - Like to see examples of EA reports employee availability, 1st and last mile, package backlog, political mail monitoring mail, etc...
 - Our political candidates are shying away from mail due to the uncertainty of timely delivery.
 - Start starting to see carriers not stopping by business and consumers for pick up and or delivery
 - Periodical service is better than in April/May but not back to normal. Weeklies need to be delivered in a narrow window.
 - In our area, overtime is still mandated for packages. However, other mail is being held. Based on postmarks and cancellations the delay is between five -seven days.
 - We are seeing mail dropshipped to the postal facilities in May, just being scanned in July. Is the mail being held at the facilities due to COVID?
 - VA CMOP is experiencing significant delays with PMOD's beyond the +1, so now add Election Mail, possible COVID and FLU increase then add Peak. Very concerned.
 - From planning perspective, what service reduction was planned as the expected outcome during the initial phase? Where are you tracking in relation to that number? When does that get recalibrated?
 - Has USPS been declining accepting packages during COVID peak?.....to what extent? local decisions of network-wide?
 - For small businesses sending packages, will the USPS continue to cut retail hours? Some areas already seeing Saturday closings.
 - Reports of locations telling customers they weren't delivering
 Periodicals or any class except first class

 Universities are coming into there peak now. We are seeing delays in incoming as well as refusal to accept outgoing due to staffing.

MTE - tray quality –

- o From Chat:
 - MTE issues in Central Missouri. Postal team is apathetic about filling the orders.
 - We send back damaged/unusable & receive it back on next order
 - Our members get tubs with no tag holders regularly
- Jason DeChambeau shared his email address
 (Jason.r.dechambeau@usps.gov) and asked for specific issues to be sent directly to him to confirm and address.
- Additional Responses: 1) to bullet items that did not have time to get to. 2) to unanswered questions in chat

1) Items that did not have time to cover

- (MKT FC) Return Mail being charged for returns of First-Class Mail, yellow stickers not being marked with fee due, and Marketing Mail continues to be returned
 - To the industry is this still and issue as mailers are reporting improvements
- (FC) Secured Destruction data fulfilment issues
 - Industry noted a drop in SD data well beyond impact due to volume.
 - Multiple issues identified:
 - 1. USPS fulfilled, but duplicate file names on EPF that mailers were not treating as 2 separate and valid files. Still, USPS has addressed to prevent duplicate file names.
 - Issue with fulfillment files from 4/1 explained as a timing issue.
 Issue addressed, populated data files posted.
 - Issues on a couple of additional dates between 2/22 and 4/26. USPS looking to re-post available scan data from identified dates.
- (FC) (FC) Discussion around Inaccurate scan data down to delivery date and closed IV tickets
 - Send for discussion in UG#4
- (MKT) What changes are needed, if any, to CSA with the new service transfer center plans - review of the new hub and spoke model for the service transfer center plan
 - More FC than MKT carry over to next MTAC
- (FC) The handling of service issues EA & Network Ops
 - Carry over to next MTAC

2) Other items from chat

 Any forecast for when there will be a selection and contract award for the Next Gen Delivery Vehicle?

- Election Mail related:
 - Political MSPs traditionally use Endicia (Stamps.com) or other vendors to generate PMOD postage labels. These MSPs have no control on STID creation. Please contact vendors to support the PMOD political STIDs?
 - Already hearing from election officials that hearing from voters that voted ballots were not picked up by carrier (along with other mail). Will there be statement/messaging from the PMG around the importance of ballots? We are already combatting the myth of fraud with absentee/VBM.
 - We anticipate 80-100M voters this November
