2.1 Data Services

The Informed Visibility Mail Tracking and Reporting (IV-MTR) data feed was updated to properly format the file using a tab to delineate the data elements. Previously, the IV-MTR incorrectly placed the characters “\t” between data elements instead of using a tab delimiter as it should have. [1277-PI](#)
