## UPDATE: Scheduled System Releases – *Sunday, January 10, 2021*

As previously advised, this Sunday (*January 10, 2021*), the United States Postal Service has scheduled software updates for the following systems which include January Price Change 2021 content (*effective date January 24, 2021*):

- **PostalOne! System Release 52.0.0.0 \* (January Price Change 2021)**
- Enterprise Payment System (EPS) Release 22.0.0.0
- Program Registration Release 22.0.0.0
- Package Platform Release 2.4.0.0

**REMINDER #1:** During the implementation and validation window (**1:00 AM CT – 1:00 PM CT**), system access will be impacted as outlined below:

After implementation concludes, users should download Mail.dat client **52.0.0.0\_PROD** from the Business Customer Gateway (BCG) using the following path: Mailing Services è Electronic Data Exchange [Go to Service] è Mail.dat download (Windows 32-bit, Windows 64-bit or Solaris).
