## 4.0 *PostalOne!* and Package Platform System — Enhancements, Updates, and New Functionality

### 4.1 Addition of Cubic Tiers to Parcel Select Ground

The USPS added cubic pricing tiers available for Parcel Select Ground. Similar to Priority Mail Cubic products this product helps customers to ship small dense packages under Parcel Select Ground prices. This product didn't apply the DIM (dimensional weight) pricing. This allows for Parcel Select Ground delivery of parcels up to 20lbs. with cubic tiers while maintaining machinability.

## 4.2 Priority Mail Cubic Removal of Minimum Volume Requirement

The USPS will support shippers by making Priority Mail cubic prices available to all Priority Mail Commercial shippers. This proposal will result in removal of the restriction that only customers shipping more than 50,000 pieces are allowed to access these rates.

#### 4.3 Centroid-based 3D/3D Zone Calculation

The USPS aligned zone determination to the customer perspective by leveraging new technology to determine distances more precisely from an origin location to a destination location. This changed the end-to-end definition of zone determination from a historically calculated facility-based 3D-to-3D ZIP Code pair to a centroid-based 3D-to-3D ZIP Code pair using entry and delivery ZIP Code-based location technology.

**The updated zone chart matrix has kept its current design/format and should not require design changes in mailing software.** The zone chart matrix will be effective with the price change effective date.

## 4.6 Direct Container Discounts for USPS Marketing Mail Flats

The USPS discounts USPS Marketing Mail Saturation and High-Density Flats that are prepared on direct containers (a.k.a. 5-Digit CRRTS, Carrier Route Pallets, and Pure Pallets, including handling units). These containers can be directly cross docked to the Destination Delivery Units (DDUs). These containers consist of Carrier Route and finer bundles such as Basic, High Density, High Density Plus and Saturation. These containers do not require bundle sorting operations, which allows the USPS to avoid moving these containers to bundle sorters within the plant, sorting the bundles, and moving these bundles back to the dock to be transported to the DDU.

### 5.3 Electronic Verification System (eVS®)

- An update was made to modify the Revenue Reallocation Report to include EPS revenue in addition to CAPS revenue. [CR 14931](#)
- An update was made to resolve the issue related to statements submitted before the payment account is activated which defaults to CAPS. [ETR 14968](#)
- PostalOne!* – eVS implemented a solution to the issue that eVS mailers manifesting with invalid permit information had pieces go to manifest errors without postage calculation being charged as per unmanifested prices (Published Prices). [CR 14900](#)
- PostalOne!* – eVS was updated to eliminate overwriting of eVS calculated flat-rate postage when the postage statement is assembled. [ETR 14901](#)
- PostalOne!* – eVS OD (Open and Distribute) single-piece records are exempt from dimensional nonstandard and noncompliance assessments. EVS incorrectly charged dimensional nonstandard and noncompliance fees for open and distribute records. [ETR 15099](#)

## 6.0 Enterprise Payment System (EPS) – Corrections to Known Issues

### 6.1 Account Alerts/Notification for Low Balance

- A USPS update created a new function to make a low balance alert, required for all EPS accounts, that are set for all product types. Low balance alerts are configurable by mailer, have a default value of \$XXXX (adjustable from the Admin Console), and are set to send to mailer and USPS. [CR 1620](#)
- A USPS update notifies the customer when their EPS account is closing due to two years of inactivity. Customers need notice to use their EPS account before two years of inactivity to keep it from closing automatically by the system. [CR 1929](#)
- An update created the capability to send communications to mailers when balance becomes/remains negative.
  - **First Negative Balance Communication** — Once an account has reached a negative balance state, a systematic communication will be sent to mailer and USPS. This communication will inform the mailer that their account is in a negative balance state.
  - **Second Negative Balance Communication** — If account balance stays in a negative balance state (more than negative \$500) for 3 calendar (make configurable) days, a follow-up communication is systematically sent to mailer and USPS stating that the account has remained in a negative balance state.
  - **Third Negative Balance Communication** — If account balance stays in a negative balance state for 6 calendar (make configurable) days a follow-up communication is systematically sent to mailer and USPS stating that the account has remained in a negative balance state. [CR 1645](#)

### 6.2 EPS Reports

- A USPS update introduced a new report that identifies mailers that have a balance below the USPS-set low-balance threshold and systematically send it to people or organizations. [CR 1621](#)
- A USPS update introduced a new report that shows transactions attempted against trust with insufficient funds and systematically send it to people or organizations. [CR 1622](#)
- A USPS update was implemented to improve *Posta/One!* Invoices within the EOD OAR invoice job. This helps make the daily cutoff consistently and removes extra conditions, adds indexes, and tweaks queries to improve performance. [ETR 2044](#)

### 6.3 ePOBOL

- A USPS update implemented a resolution to allow EBill to systematically retry sending ePOBOL returns to ePOBOL. [ETR 2014](#)
