- USPS will add a month.dat file to the CD. This will allow licensees to know what file date is on each CD in case there is any confusion. The new file will be available in the November 2005 Product.

RDIVOLCDSSTD.DOC – March 11, 2004

- Volume ID on the CDs will be as follows every month: USPS_RDI_MMDDYY. For example, USPS_RDI_031504. This will allow customers to see the same format every month for programming purposes.
