- Mail.XML now identifies hazardous material when users make appointments. The value must be stored within the following tables:
 - Drop Ship APPT
 - Australian Dollars (AUD) APPT
 - Origin Entry (OE) APPT
 - AUD OE APPT [REQ 1851](#)

2.2 Facilities Database (FDB) Updates

- FAST was updated to accept the following new subtypes from FDB:
 - RPDC – Regional Processing Distribution Center
 - SDC – Sorting and Delivery Center
 - SFSC – Stamp Fulfillment Service Center
 - SDC DLV ONLY – Sorting and Delivery Center - Delivery Only [REQ 1865](#)
