On Sunday, February 10, 2019, the United States Postal Service implemented the following software change:

- *PostalOne!* System Release 48.0.2.0

2.0 Mail.dat Client Support

Please note the following regarding the Mail.dat client download.

There was no new Mail.dat client version required with this release. Users should continue to use **Mail.dat client version 48.0.1.0_PROD or 48.0.0.0_PROD**. The current **Mail.dat client** may be downloaded from the Business Customer Gateway (BCG) using the following path: Mailing Services → Electronic Data Exchange [Go to Service] → Mail.dat download (Windows 32-bit, Windows 64-bit or Solaris).

3.0 *PostalOne!* System – Corrections to Known Issues

3.1 eInduction

For Mail.dat submissions with “CATLOG” (catalog) in the Component Characteristic Record (.ccr), eInduction logic was updated to enable the Intelligent Mail® container barcode (IMcb) to be released to Surface Visibility (SV). Previously, for Mail.dat submissions that included catalogs in the .ccr, the eInduction logic did not recognize “CATLOG” as a valid processing category, which prevented the success message from generating to pass the container to SV. 3.2 *PostalOne!* System Interface with Enterprise Payment System (EPS)

The *Postal One!* System interface with the Enterprise Payment System (EPS) was updated to send Total Pieces to EPS for Return transactions involving an EPS account. For Returns, the Total Pieces were previously missing from the transaction details that the *PostalOne!* System sent to EPS. [12992 \(20301-R\)](#)
