1.0 Introduction

On Wednesday, April 24, 2019, the United States Postal Service implemented the following software changes:

2.0 Package Platform – Corrections to Known Issues

2.1 Reporting Service

The reporting service has been updated to correct a timing issue in order to enable the report generation time to consistently match the start time of the subscription. The issue impacted existing report subscriptions for which the subscription time and/or frequency was updated after the initial setup. When the subscription start time or frequency was updated, duplicate files were sometimes produced. The timing logic was adjusted to begin the updated start time or frequency at the time of the request for the current day. New report subscriptions for which the subscription time and/or frequency was not updated were not affected by this issue. [423-P \(1444-R\)](#)
