Session 1: PERIODICALS

Marc Overview - Action Items Review

- Provide a go live date for FPP status on long run CPP titles process.
- Seamless Acceptance verification process for exceptional dispatch periodicals (newspapers).
- Identify a process to facilitate a collaborative discussion on piece weight verification on flats.
- EPS -Report of mailer running into problem when they didn't finish the set-up for EPS in one sitting.

Centralized Postage Payment

Long run CPP titles pilot with the continuous MID is to marry the elnduction with CPP together.
Containers that are showing as not in the FPP status are displayed as payment errors. The
workaround for this is to identify and isolate the payment errors and removed them from the
scorecard and perform a monthly validation/sampling of those containers to assure payment.
This would be validated by a matrix.

Seamless Acceptance

- Limited on Full Service Exceptional Dispatch for periodicals.
- For FY19 26.8B or 41% of commercial mail volume on Seamless Acceptance.
 - o 20.5% Flats
 - o 79.5% Letters/Cards
 - o 459 or 4.1% of CRIDS are on Seamless
- Proposed FRN in Sept 2019
- Seamless by Sept 2020 with a retirement of manual verifications by Feb 2021.
 - Suggestion was made to push back after the holiday season to 2021
- A proposal was made to use estimated piece weight provided by MSP whereas USPS cannot accept estimated weights due to multiple versions within a co-mailing from variable weights e.g. poly bags, variable ride-along content etc.
 - Suggestion was made to take current process and convert to a certification process/audit on a scheduled basis

- o Certification process would be based on trust
- 90% full service is a concern with multiple titles (PER) due to dropping overnight where eDocs are not submitted till later in the day however the PERs are dropped early in the morning.
- Timeline to verify after the mailing has gone due to external conditions that may affect paper weight bringing it back to a certification process.
- Auto-finalization of Seamless postage statements even if permit fees are due for renewal.

Mail Irregularities

- Replacement of eMIR legacy is due to reporting submission awkwardness.
- Enabled SV scanners to report irregularities with a future IV Automated Bundle Report.
- June 23, 2019 a new Mail Irregularities (MI) tab will be added to the Mailer Scorecard.
- Mid July to test with selected mailers.
- Test groups issues with descriptions not being clear. List was created to review and edited to
 provide better resolutions and understanding of the eMIR issues.
- Operations is responsible for logging eMIR issues and will be trained to provide clearer discerptions with DMM instructions to recognize exceptions that do not need to be logged.
- Bundled breakage will appear on both MSP and Mail Owner score card.
- One image would be provided can take up to 3 images of the emir issue.
- Score card will be viewed as warnings and not errors.

Marc Overview - Action Items Review

- Price change DIM this Sunday, June 23, 2019
- Provide update on Package Platform
- Provide update on package transition to EPS
- Package Platform -Add the ability for shippers to indicate "soft pack" in the shipping Services File (SSF)

DIM

- Priority Mail Express, Priority Mail, and Parcel Select packages over 1 cubic foot for all zones will be eligible for DIM-weight pricing
- Continue with the current method of PAF for dimensional weight assessment and samples will be incorporated into the PAF calculation with anomalies reviewed on a case by case basis.
- Packages will be sampled and dimensions will be captured as applicable
- 1.5% threshold will be applied to monthly samples
- Scenarios were provided (6) Manifested DIM weight, Calculated DIM weight, and Manifested pkg weight.
- Accurate data input was stressed for accurate DIM assessment. Expectations are on shippers to input correct data in regards to DIM assessment.
- Customer indicated to clarify scenario to avoid excessive postage assessments. USPS will use
 actual weight to assess DIM. Customer indicated all of this information is new and the impact to
 deploy within such a short time frame. Business rules were set earlier in the quarter however
 new business rules recently applied for mailers to comply is unreasonable without customer
 testing and modifying current software. Mailers are indicating there is little ramp up time to
 implement.
- New business rules are creating a new level of complexity. Members inquired for a trial period with the new DIM rules to adjust their manifesting systems.
- Automation will not capture weight to flag sampling. Process will be done manually. Ratio of sample is done by volume. From a statically perspective on sampling USPS looks for with margin of error. Below 250 pcs will not be sampled. Sample on NSA items will be charged as a NSA priced. There will be visibility towards sampling (PAF) and adjustments. Our intention is not to collect PAF but to have mailers enter correct manifest data. PS and Priority/Express on all samples regardless of DIM.
