Labor Talks - USPS, Unions Begin Negotiations

The Postal Service began negotiations this week on new labor contracts with two unions that represent USPS employees. Postmaster General Megan J. Brennan and the Postal Service's bargaining representatives met with leaders of the National Association of Letter Carriers (NALC) and the National Postal Mail Handlers Union (NPMHU) at USPS headquarters in Washington, DC.

Negotiations with the NALC, which represents approximately 210,000 employees, began June 26.

Negotiations with the NPMHU, which represents approximately 44,000 employees, began June 27.

The Postal Service's current contracts with both unions expire Sept. 20.

"The Postal Service looks forward to productive negotiations with both the National Association of Letter Carriers and the National Postal Mail Handlers Union," said Brennan. "With each union, we will seek an agreement that is fair to our employees, fair to our customers, recognizes the realities of today's marketplace and positions the Postal Service for success moving forward."

High Marks - USPS Named One of the Nation's Best Employers

The Postal Service has been named one of the nation's best employers in a *survey of 50,000 U.S. workers*. Forbes magazine partnered with market researcher Statista to identify the organizations in each state and Washington, DC, that employees most favored and would likely recommend to others.

USPS ranked second on the list behind the U.S. Department of Defense. Workers in 28 states named the Postal Service a best employer. Other employers in the top 10 include Marriott International, Target, JPMorgan Chase and UnitedHealth Group.

Respondents were asked to rate, on a scale of 0-10, how likely they'd be to recommend their employer to others. They were also asked to nominate organizations in industries outside their own. The survey indicates having a mission employees believe in is key to an organization being considered one of the best places to work.

"Service — it's part of our name. We are here to serve and support our communities," Jeryl Wilson, the Postal Service's diversity and talent acquisition director, told Forbes.

Job opportunities were also cited in the report as a reason workers thought favorably of the Postal Service, which offers more than 2,400 career paths.

Said Wilson: "There are great opportunities for growth, development and advancement within our organization. Those are the things that I think are important for employees to know about."

Growing Businesses - Entrepreneurs Learn More About USPS

The Postal Service wants to help small-business owners find better ways to contact customers and grow their companies, USPS leaders told entrepreneurs at a recent symposium. The event, held in Washington, DC, allowed small-business owners to learn about the latest postal products and services to help them better target and reach consumers.

Attendees learned about Every Door Direct Mail, return shipping services, Informed Delivery and services under development. There also was a question-and-answer discussion with small-business owners who are using USPS products and services to meet their marketing and delivery needs.

The symposium, organized by Capital Metro Area and Capital District, was held at the National Postal Museum. The meeting was part of the Postal Service's broader initiative to attract small-business customers and grow revenue. Other efforts include holding Grow Your Business Day events at Post Offices and participating in National Small Business Week each year.

Cronkhite Named Chief Human Resources Officer



Isaac Cronkhite has been named the Postal Service's chief human resources officer, a position he *held on an acting basis* since January. Cronkhite leads the organization's efforts to engage employees, strengthen workplace experiences, and foster and cultivate talent to ensure workers are positioned to meet customers' evolving needs.

In a June 13 memo announcing Cronkhite's appointment, Postmaster General Megan J. Brennan wrote that he is "a transformational leader, highly focused on enabling, empowering and developing the men and women of our workforce.

Throughout his career, he has been at the forefront of efforts to better leverage technology, data and business insights to enhance performance and unlock the potential of our people."

Cronkhite previously served as enterprise analytics vice president, where he oversaw the implementation of the Internal Service Performance Measurement (SPM) system, led the Customer Experience Council, provided real-time analytics and network performance information to customers, and directed the rollout of diagnostic tools. He also developed and launched Analytics University, which provides training to more than 29,000 frontline supervisors and managers.

Other previous assignments include processing operations manager in Washington, DC; senior plant manager in Richmond, VA; and plant manager in Brockton, MA.

Presidential Salute - George H.W. Bush Stamp Arrived June 12



The Postal Service released a stamp honoring former President George H.W. Bush on Wednesday, June 12. Bush, who served as the 41st president from 1989-1993, died last fall at age 94.

During his term in office, he guided the United States and its allies to a peaceful end to the Cold War, helped reunify Germany, and led a multinational coalition that successfully forced Iraq to withdraw from Kuwait during the Persian Gulf War.

On the domestic front, Bush signed historic legislation to integrate Americans with disabilities more fully into society, as well as a Clean Air Act update that tightened air pollution

standards and reduced urban smog and acid rain.

The stamp art is a portrait of Bush painted by award-winning artist Michael J. Deas. The image is based on a 1997 photograph taken by Timothy Greenfield-Sanders. Phil Jordan served as the art director and stamp designer.

The stamp was announced in April and will dedicated on June 12, the president's birthday, at the Annenberg Presidential Conference Center in College Station, TX.

Robert M. Duncan, chairman of the Postal Service Board of Governors, served as the dedicating official.

The stamp will be available at Post Offices and usps.com.

The Postal Regulatory Commission (PRC) favorably reviewed an updated weight limitation for First-Class Mail International® (FCMI) large envelopes (flats) in PRC Order No. 4932, issued December 19, 2018, in PRC Docket No. MC2019-3. On March 11, 2019, in a filing at the PRC, the Postal Service announced an implementation date of June 23, 2019, for the revised FCMI large envelopes (flats) maximum weight limitation. The Postal Service has made the accompanying classification changes to Mailing Standards of the United States Postal Service, International Mail Manual (IMM®) in order to reflect this revised weight limitation.
