





CONCERN

EPS system has data, **EPS IV Data** does not.

Example: Periodicals Postage Statement Details data missing number of pallets and number of bundles.

Better **communication** of changes to reports and data format in USPS systems (EPS, Mailer Scorecard) **when updates are performed**. Many industry participants use automated scripts to track financial information. Several missed announcement of recent changes and **didn't have scripts in place to accommodate**.

DISCUSSION

"0" counts for pallets/bundles/sacks for Periodicals is "0" in both EPS reports and in IV-MTR because it is not provided to EPS by *PostalOne!*. This is PO ALM 13986 and is scheduled to be fixed no later than Labor Day.

Is it possible to create additional communication (alert) that the appropriate end user will receive in addition to the Release notes and Industry alerts?




