1.0 Introduction

On Sunday, September 13, 2020, the United States Postal Service implemented the following software changes:

- Enterprise Payment System (EPS) Release 4.0.1.0
- Facility Access and Shipment Tracking (FAST) Release 47.0.0.0

These Release Notes provide the contents of the releases and affected subsystems.

The sections titled ***Corrections to Known Issues*** are derived from External Trouble Reports (ETRs) and Engineering Change Requests (ECRs) for inclusion in these releases.

This document is prepared based on the knowledge available at the time of its publication and any element may be subject to change prior to publication.

2.0 Enterprise Payment System (EPS) - Corrections to Known Issues

2.1 Reports

The Commercial Mailing and Shipping Details Report export functionality was updated to properly reflect all data matching the report criteria. Previously, attempts to export the report resulted in an export file containing column headings only (i.e., no data), even though all data was properly reflected on the online report page in EPS. 3.0 Facility Access and Shipment Tracking (FAST) – Corrections to Known Issues

3.1 Appointments

- The Manage Existing Appointment module was updated to enable users to add an additional appointment to a Multi-Stop appointment. Previously, if a different Shipper Name was used for the new appointment, the additional appointment could not be created. [1610-F](#)
- The Confirm Recurring Appointment Information page was updated to remove the text “*Are you sure you would like to update the following recurring appointment?*”. This confirmation text is not needed here since confirmation of the appointment update has already taken place in an earlier step. In addition, the information specifying the timeframe for instances of the recurring appointment was updated from “14 days” to “21 days”. (“*Instances for the next 21 days have already been created for this recurring appointment and are displayed below.*”) [1615-F](#)

3.2 Reports

The Appointment Status Report was updated to properly search by Appointment ID in cases where the appointment is unscheduled. Previously, this type of search did not return any results even when data existed for the search criteria. [1611-F](#)
