The USPS is instituting a fee to discourage mailpieces that exceed the maximum size allowed for mailable items. Currently, a fee is only charged when a piece that weighs over 70 pounds has entered the USPS network (Overweight fee). The change will apply a similar fee to any item that exceeds 130 inches in length and girth (Oversize fee). Except for an overweight or oversize item discovered and picked up at the same facility where it was entered, the Overweight/Oversize Item Fee of \$100.00 will be assessed and must be paid before release of the item. The \$100.00 Overweight/Oversize Item Fee may be paid by any authorized retail or commercial payment method.




