**Industry Leader - Lisa Wurman
Postal Leaders – Marc McCrery & Tom Foti**

Action Item: Mailer Scorecard – mailers are experiencing errors on scorecard (December 2020, January 2021, February 2021) due to late mail. What will the policy be on scorecard assessments resulting from these errors? **(Foti)**

Action Item: Review policy for late mail which caused mail to be “wasted” – marketing value lost (delivered after sales date, etc.). Marketers seeking refunds. May need to work in conjunction with operations/processing to implement a mechanism for MSP/MO to decide if mail should be delivered when it will be delivered outside of service standard. **(Foti)**

Action Item: Consider changing uniqueness requirement from 45 days to 90 days – would this mitigate scorecard errors due to late mail? **(Foti)**

Action Item: Allow industry participation in USPS policy discussion or at least allow industry provide education on the impact of late mail across the entire supply chain. **(Foti)**

Action Item: Undocumented Error Matching Process Improvement – can the USPS use the MQD files instead of having the industry manipulate those files and send them back to the USPS? At a higher level – can USPS run barcodes through the process before deeming them undocumented? **(Smith)**

Action Item: BCG – Customer Validation Tool – fact sheet requested for users.

Action Item: Revamping of FAST system – need collaboration between USPS Operations (Ramirez), USPS Commercial Systems(Bosch) and Mailing Industry. **(Bosch)**

Letters:

Action Item: EMCA Migration to NCMS – some customers are required to do a security check/audit to make sure USPS systems meet requirements. What group does this fall under at USPS and who is the contact? **(Arcari)**

Packages:

Action Item: Additional training need for HQ eVS analysts on EPS conversion. John Medeiros to provide examples of gap. **(Smith)**

Action Item: DIM Measurements – non-rectangular pieces are measured as rectangular. USPS requested examples, Steve Smith and John Medeiros to provide examples. Will require further discussion after USPS receives examples. **(Bosch)**

Flats:

Action Item: MSP Balance Check – fact sheet(s) on process for mail owner to allow access to EPS and Local Trust account balance and for MSP to obtain balance. **(Egloff)**

Action Item: MSP Balance Check – walk through how it works at next UG 11 meeting on February 4, 2021. **(Duffy)**

Action Item: What is the plan for allowing industry access to archived CAPS data? SOX requires financial records to be stored for 7 years.

- All classes and shapes – as well as remittance and UAA
- Impact & performance on all classes of mail (how much late and by how much)
- Why all classes and shapes impacted when many had lower volume than SPLY

Action Item: Request for USPS to partner with industry for case studies of mailer “Peak” experience to coincide with USPS after-action-review; share lessons learned, real-time adjustments, and after-action review findings **(TBD)**

Action Item: Provide defined hierarchy for issue escalation and consistent/accurate messaging (current mailer experience not matching data reported by operational sites); per Dale, start with BSN/Sales - **Erika Ramirez**

Discussion Topic: Communication

Action Item: Request to establish Task Team for industry to provide input on the USPS Industry Connect Dashboard - **Erika Ramirez**

Action Item: Request for weekly industry call to discuss processing/logistics conditions; provide current status and projection for upcoming week with open dialog - **Erika Ramirez**

Action Item: Develop plan to provide better communication to package shippers for future DDU redirects during Peak to Annexes - **Jason McAlister**

Action Item: Provide additional info/discussion on open items and schedule for Address Quality Cycle O - CASS and NCOA Link which need to follow the same timelines - **Jim Wilson**
