## 2021 Price Change Filing Webinars Tuesday, June 15 at 12 noon (EDT) and Friday, June 18 at 3pm (EDT)

The United States Postal Service filed notice on May 28, 2021 with the Postal Regulatory Commission (PRC) of price changes to take effect on August 29, 2021.

Sharon Owens, VP-Pricing & Costing, will present two webinars, open to all mailing and shipping customers. The first is scheduled to take place on Tuesday, June 15 at 12 noon (EDT) and the second, hosted by the Postal Customer Council, will take place on Friday, June 18 at 3pm (EDT).

The webinars will provide highlights of the price change, and among the topics covered, will be details related to the change for FCM non-automated letters, high density flats pricing on direct pallets, and 2022 mailing promotions.
