1.0 Introduction

On Sunday, June 27, 2021, the United States Postal Service implemented the following software changes:

- *PostalOne!* System Release 52.1.2.0
- Business Intelligence Data Store (BIDS) Release 53.0.0.0
- Enterprise Payment System (EPS) Release 4.3.1.0

These Release Notes provide the contents of the release and affected subsystems.

The sections titled ***Corrections to Known Issues*** are derived from External Trouble Reports (ETRs) and Engineering Change Requests (ECRs) for inclusion in this release.

This document is prepared based on the knowledge available at the time of its publication and any element may be subject to change prior to the release.

2.0 Mail.dat Client Support

Please note the following regarding the Mail.dat client download.

There is **no** new Mail.dat client with this release. Users should continue to use Mail.dat client **52.1.0.0_PROD**, which was required with *PostalOne!* System Release 52.1.0.0 on April 25, 2021. Mail.dat client **52.1.0.0_PROD** can be downloaded from the Business Customer Gateway (BCG) using the following path: Mailing Services → Electronic Data Exchange [Go to Service] → Mail.dat download (Windows 32-bit, Windows 64-bit or Solaris).

3.0 *PostalOne!* System – Corrections to Known Issues

3.1 *PostalOne!* System Interface with Enterprise Payment System (EPS)

The *PostalOne!* System interface with EPS was updated to include the Processing Category and Form Type in the EPS bulk transactions. This information enables EPS to determine the mail class category for use in reporting. [14563 \(22382-R\)](#)

4.0 Business Intelligence Data Store (BIDS) – Enhancements, Updates, and New Functionality

4.1 MicroStrategy Reports

The eDoc Submitter Mailer Scorecard was updated to display Automated Verification data. To accommodate this, the following changes apply:

- The Mailer Scorecard tab was renamed from “Seamless” to “Seamless – Automated Verifications”.
- A red banner message was added to the Mailer Scorecard stating: “*Undocumented errors are excluded for Automated Verification mailers*”
- A new breakout section was created on the Seamless – Automated Verifications tab, labeled “Undocumented Error Data” and includes the # Undocumented Pieces and Additional Postage Due – Undocumented. [88-B](#)

5.0 Enterprise (EPS) – Corrections to Known Issues

5.1 Account Management

EPS automatic account closure logic was updated to include consideration of adjustment, refund, reversal, and Centralized Account Processing System (CAPS) trust balance migration transactions when determining whether any activity has taken place on the account within the threshold timeframe (currently set to 2 years). Prior to this release, only purchases, deposits, transfers, and withdrawals were accounted for in the determination. This change also prevents accounts from being closed automatically if any of these additional transaction types are detected in the threshold timeframe. [1939-ER](#)

5.2 Payment Methods

A defect was corrected that previously prevented customers from being able to delete an Automated Clearing House (ACH) Debit payment method linked to their account, even though they had no ACH Debit transactions pending for the payment method. [1927-ER](#)

5.3 Reports

EPS was updated to revise the method used for determining the mail class category so that it uses the Processing Category and Form Type sent by the *PostalOne!* System for postage statement transactions. Previously, EPS used another method to determine the mail class category; however this could sometimes result in the mail class being updated after the initial transaction was processed. The updated method allows the mail class to be assigned at the time that the financial transaction is processed. [1868-EI](#)
