[REMINDER: APRIL-PRICE-CHANGE-2022] Commercial Systems' Activity – Sunday, April 03, 2022

As previously advised, in support of **April-Price-Change-2022** (effective **April 03, 2022**), this **Sunday, April 03, 2022** [from **6:00 AM CT – 11:00 AM CT**], the United States Postal Service will implement software updates for the following Commercial System:

- **PostalOne! System Release 54.1.1.0**

NOTE: As referenced in release documentation, other Commercial Systems with Pricing dependencies will also be updated accordingly.

During the cited implementation and validation window (6:00 AM CT – 11:00 AM CT), **system access WILL NOT be impacted**. However, although unanticipated -- if a connectivity issue is experienced, users are encouraged to log-in again. Immediately after this system activity concludes, notification will be provided.

REMINDER: There is no new Mail.dat client required for *PostalOne!* System Release 54.1.1.0 on Sunday, **April 03, 2022**. However, as a **REMINDER - PostalOne! System Release 54.1.0.0 on March 20, 2022 included a new REQUIRED Mail.dat client**. Users should download Mail.dat client **54.1.0.0_PROD** from the Business Customer Gateway (BCG) using the following path: Mailing Services → Electronic Data Exchange [Go to Service] → Mail.dat download (Windows 32-bit, Windows 64-bit or Solaris).
