### 3.0 Direct Container Discounts for USPS Marketing Mail Flats

The USPS is considering a discount for USPS Marketing Mail Saturation and High-Density Flats that are prepared on direct containers (a.k.a. 5-Digit CRRTS, Carrier Route Pallets, and Pure Pallets, including handling units). These containers can be directly cross-docked to the Destination Delivery Units (DDUs). These containers consist of Carrier Route and finer bundles such as Basic, High Density, High Density Plus and Saturation. These containers do not require bundle sorting operations, which allows the USPS to avoid moving these containers to bundle sorters within the plant, sorting the bundles, and moving these bundles back to the dock to be transported to the DDU.

- Postage Statement Changes - PS Form 3602 R/N

The Direct Pallet/Bundle lines (Basic – CR Bundle/Pallet and High Density – CR Bundles/Pallet) prices will be removed. New discount pricing lines will be added, these new lines represent the direct container discounts. New container discount lines will be available for: Saturation & EDDM, High Density Plus, High Density, and Basic sorts. Any pieces nested on Direct containers must be documented on the Direct Container discount lines.

The following lines are added. For a final list of lines, please refer to the draft Postage Statements (to be published on Postal Explorer; pe.usps.com). The subtotal containerization discount is subtracted from the subtotal piece postage.

## 4.0 Non-automated DVD Price Structure Change

The USPS is considering adding Mixed AADC and AADC prices for Nonautomation Round Trip Mailings that contain a DVD, CD, or other disk. This structural change will align the DVD price structure to the letter price structure for Market Dominant First-Class Mail.

- Postage Statement Changes – Yes - PS Form 3600 FCM

“Part D - Round Trip Mailing that Contain a DVD, CD, or Other Disc,” Section: “Presort Letters” is relabeled as “Machinable Letters.” ‘Presorted’ rate is replaced with ‘AADC’ and “Mixed AADC.”

“Part D – Round Trip Mailing that Contain a DVD, CD, or Other Disc,” Section: “Presort Flats” is relabeled as “Nonautomation Flats.” ‘Presorted’ rate is replaced with ‘ADC’ and “Mixed ADC.”

FCM Machinable *Letters* Presorted sort will be replaced with AADC, Mixed AADC. Nonautomation *Flats* Presorted sort will be replaced with ADC and Mixed ADC sorts.

## 5.0 Eliminating Special Handling-Fragile

The USPS is considering discontinuing the Special Handling-Fragile Extra Service. This Extra Service is currently available for domestic mail and can be added at the time of mailing. This Extra Service is currently supported for Priority Mail, Priority Mail Express, First-Class Package Service, Parcel Select Ground, and Parcel Select products.

## 6.0 Qualified Business Reply Mail Uniform Rate

The USPS is considering creating a new QBRM product that has a single price for QBRM Letters (this includes Basic and High Volume QBRM) weighing up to 3.5 ounces. This proposal anticipates making use of the Intelligent Mail Barcode Accounting (IMbA) process for automated accounting to reduce the amount of manual handling of BRM mail pieces, and to make Reply Mail processing more efficient.

## 7.0 Centroid-based 3D/3D Zone Calculation

The USPS is considering aligning zone determination to the customer perspective by leveraging new technology to determine distances more precisely from an origin location to a destination location. This changes the end-to-end definition of zone determination from a historically-calculated facility-based 3D-to-3D ZIP Code pair to a centroid-based 3D-to-3D ZIP Code pair using entry and delivery ZIP Code-based location technology. The updated zone chart matrix will keep its current design/format and should not require design changes in mailing software. The zone chart matrix will be effective with the price change effective date.
