Promotions- Heather Lewis needs sample of why (Rose will send to her)

- Tom Foti asked for more detail, score card reports total savings is not correct, contacted USPS about issue.
- Tom Foti- is this product specific or promotions, looking for gaps (Rose stated she will get details from Carol Kliewer and that Steve Krejcik is looking at this too)
- Heather asked how many mailers this issue effects (Rose will follow up with Heather Lewis)
- Undocumented Warning Chip Brown

Undocumented Warning/CAT 14

- Category 14 Undoc is reassigned when a 1:1 MID relationship has been established via eDoc to an eDoc Submitter. Initially deployed January 2022.
- Phase I enhancement to the logic occurred on 5/23/2022.
- Phase II enhancement to the logic scheduled for 8/28/2022.
- Category 14 Undocumented is scheduled to become an assessable error for Seamless eDoc Submitters on January 1, 2023

- Bulk upload can only do 1,000 pcs at a time, disputes can only be done one at a time instead of entire sheet
- Bulk Dispute is the issue we'll investigate with Thomas Andrews (Foti)
