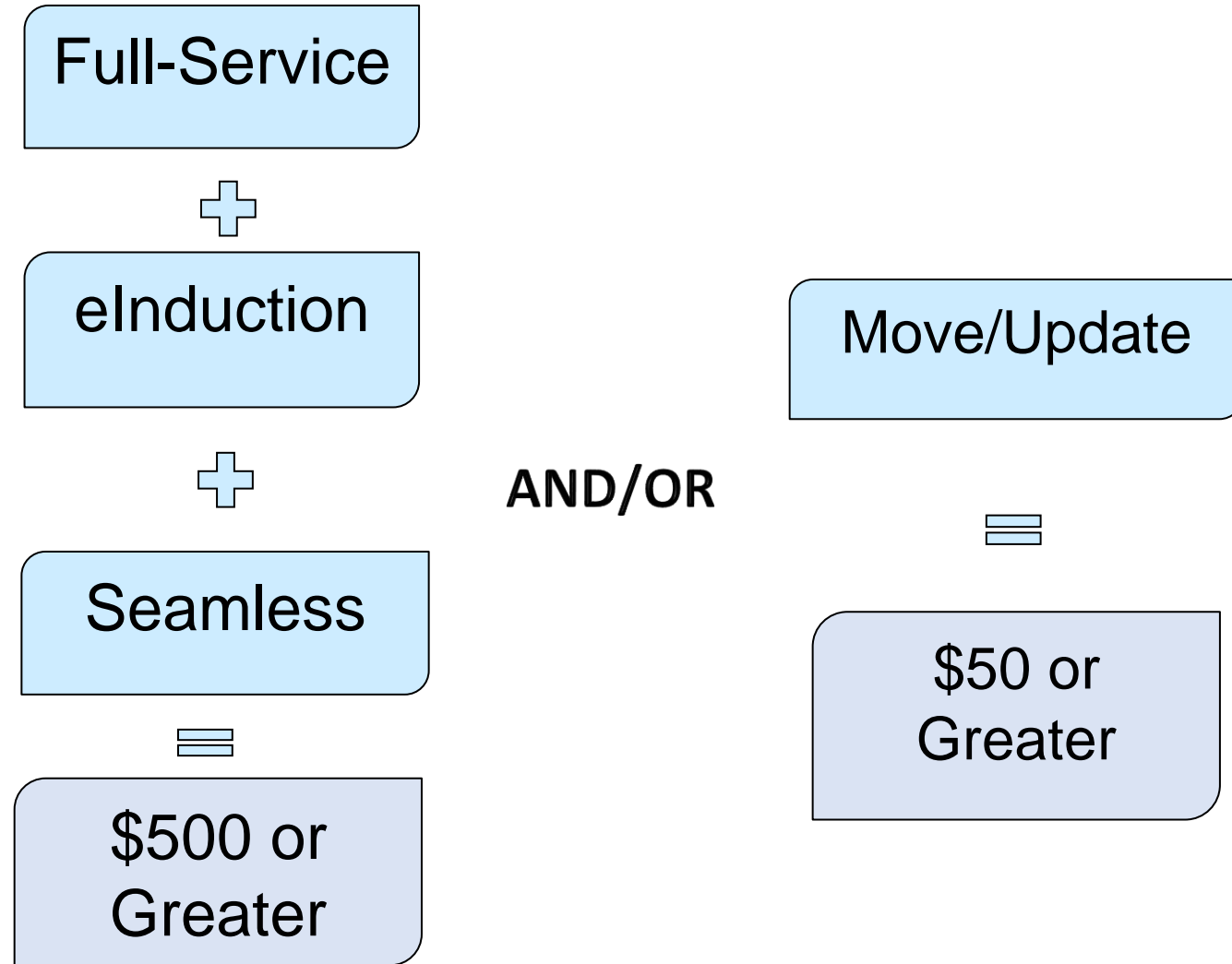
Jan 2023 Pre-Release Notes Update

Assessment Threshold Change

Minimum assessment thresholds will change beginning with the September mailer scorecard

- A mailer will only receive an assessment if the sum of assessable amounts across Full-Service, eInduction and Seamless is \$500 or greater
- A mailer will only receive an assessment if the assessable amount for move/update is \$50 or greater.
- The mailer will be assessed both amounts if they are over \$500 for FS, EID and Seamless, while also over \$50 for MU



New Category 14: Single MID-CRID Relationship

- Initially deployed on 1/23/2022 to allow an undocumented piece to be reassigned to the single known eDoc Submitter for the MID in the undocumented barcode
- Category 14 initially took precedence over the existing 13 categories of undoc.
- Mailers were initially given a grace period (1/23 – 4/30) to resolve single MID-CRID undocumented mail issues

- Phase I enhancements were implemented on 5/22/2022
 - Revised error logging reassignment order of precedence
 - Exclude MIDs belonging to known MSP's from Category 14 reassignment
 - Expand MID to eDoc CRID relationship identification window to 180 days
- June data shows a decline in Category 14 reporting to Seamless mailers from an avg of 19.71% in previous months to 12.85% in June.

New Category 14: Single MID-CRID Relationship

Phase II enhancement release is moved up to 8/14/2022

- Undoc assignment defined by Seamless Admin set-up of MID becomes 1st priority of reassignment
- Establish a minimum MID usage threshold (25 pieces in a single job) to determine Category 14 eligibility
- Exclude piece scans with a STID mail class that is not identified in the eDoc submission from Category 14 reassignment
- SASP to include PW and hardcopy statement submission when determining if a MID belongs to a known MSP

Grace period has been extended until 1/1/2023

- Category 14 errors will become assessable with January assessments on February 11th 2023.
