USPS Ship TEM

USPS Ship has a TEM environment to support shipper testing

- Shippers will need to contact USPS to enroll in USPS Ship TEM if not already enrolled in USPS Ship production
- Once enrolled in TEM, shippers can submit Shipping Services Files (SSFs) versions 1.6, 1.7 and 2.0 via DTS which will be automatically passed to USPS Ship
- For results of file processing
 - Now Shippers can request their manifest pricing and errors/warning results
 - **Future** Shippers will review their USPS Ship reports in TEM (date TBD)
- Enhancement from eVS: Shippers will receive their contract pricing in USPS Ship TEM
