Webinar for Upcoming Changes to Enforcement of Requirements for Custom Labels on MPO/DPO Mail- January 6th at 3:30pm

Please join us this Friday, January 6th from 3:30 to 4:15 EST, as we highlight the important upcoming changes in enforcement of longstanding rules surrounding the requirement for data and customs labels on MPO/DPO mail (Military Post Office or Diplomatic Post Office) and provide information on the presence of Dangerous Goods on International Airplanes.

The PC Postage Industry has a unique implementation which reaches many different types of mailers (from the largest to the smallest) and must be made aware that their software may not be following requirements for submission of D3/D4 Shipping Services File information when “Domestic Rate” pieces are flying internationally to their destination (MPO/DPO).

Any software provider who assists in preparing mail, creating Customs Forms, sending items to Military or Diplomatic destinations must understand the requirements that apply to their software and their mailer's items. While the mailer must submit a shipping services file to the USPS, depending upon how the PC Postage Vendor is integrated with the software package and logistics tools, it may be the PC Postage Vendor who should submit these files to the USPS on behalf of the mailer.
