#### 1.0 Introduction

This document includes planned changes under review for the next release scheduled for October 2023.

# 2.0 USPS Ground Advantage Intelligent Mail package barcode (IMpb) Compliance

USPS Systems will be updated to enable the compliance evaluation for IMpb Barcode Quality (BQ) for USPS Ground Advantage on October 1, 2023.

The Barcode Quality (BQ) will be evaluated for the following:

- Manifest validation for correct Service Type Code (STC) compared to:
  - Rate ingredients for USPS Ground Advantage (see Appendix A)
  - Weight in the manifest
- Label validation for correct:
  - Service Type Code 001, 346
  - Service icon G
  - Banner text USPS Ground Advantage
  - Indicia Mail Class USPS Ground Advantage

Noncompliant packages that exceed threshold for IMpb (BQ, 98%, MQ, 94%, AQ, 90%) will be assessed on the compliance category with the greatest number of packages over threshold.

Refer to Publication 199: Intelligent Mail Package Barcode (IMpb) Implementation Guide for Confirmation Services and Electronic Payment Systems for IMpb compliance information.
