Hard Copy Postage Statement Discontinuance Featuring Laura Olson and Bill Gridley



Please join the National PCC Program Office on *Friday, March 8, 2024, at 2:00 PM Eastern Time* for a virtual session covering *Hard Copy Postage Statement Discontinuance*. This information will be presented by guest speakers Laura Olson, Business Solutions Training Developer and Bill Gridley, Business Systems Analyst Principal.

USPS is amending Mailing Standards of the United States Postal Service, Domestic Mail Manual (DMM®) in various sections to discontinue the use of hardcopy postage statements for domestic commercial mailings. A Federal Register Notice (FRN) with the final ruling on the discontinuance of hardcopy postage statements was published April 25, 2023, effective January 28, 2024. Currently the USPS has allowed a Grace Period until March 31st for mailers to seek assistance to transition to electronic submission.

We will discuss opportunities to reach a unique membership base in an effort to assist with this USPS mandate.
