Mail Direction Files (MDF)

The February Mail Direction File with an effective date of March 1, 2024, has been republished to update the file previously issued on February 10, 2024. This file is being republished to support pallets being accepted at the Atlanta RPDC starting March 1, 2024.

The republication of the files allows Mailers to claim the SCF and NDC discounts when applicable starting March 1, 2024 at the below facility.

- Destination Entry drop shipments of parcels to 298, 308-309 for SCF discount will be at the Atlanta RPDC (formerly in Augusta) *revised from past notice
- Destination Entry drop shipments of parcels to 300, 305-306 for SCF discount will be at the Atlanta RPDC (formerly in North Metro) *revised from past notice
- Destination Entry drop shipments of parcels to 301-303, 311, and 399 for SCF discount will be at the Atlanta RPDC (formerly in Atlanta) *revised from past notice
- Destination Entry drop shipments of parcels to 304, 310, 312, 318-319 for SCF discount will be at the Atlanta RPDC (formerly in Macon Holt Annex). *revised from past notice

Update: New Atlanta GA Regional Processing & Distribution Center Goes Live February 24, 2024

Effective with the March 1st Label List updates, Destination Entry drop shipments of letters, flats, and parcels to 242, 298, 300 – 312, 318 – 319, 350 – 352, 354 – 368, 373 – 374, 376 – 379, 394 – 395, 399, 407 – 409, 417 – 418, and 425 – 426 for NDC discount, will be at the Atlanta GA RPDC (NASS Code 302RP; Locale Key: 020303).

The Atlanta GA RPDC will accept SCF Destination Entry volumes for SCF prepared parcel containers for 298, 300 – 306, 308 – 312, 318 – 319, and 399.
