- Added section 5.11 regarding the creation of a centralized email address for USPS correspondence.
- In section 6.1, changed 'tables' to 'product.'
- In section 6.3.1, changed 'valid' to 'known.'
- Added section 6.4 regarding the creation of a centralized email address for USPS correspondence.
- In section 7.6.3, added 'requirements' after 'Stop Processing.'
- In section 7.7.1, added 'data' after 'DPV.'
- In section 7.7.2 in the first sentence, reworded the phrase 'delivery point validating of addresses' to 'validating delivery points of addresses.' In the fourth and fifth sentence, changed 'Licensee' to 'End User' and in the fifth sentence, changed 'customer' to 'Licensee.'
- In section 7.7.3, created a complete sentence from the information in parentheses. The sentence states 'This code cannot be used after the first occurrence to bypass any further stop processing error codes.'
- In section 7.7.5, changed 'customer's' to 'End User's.'
- In section 7.9.1, added 'data' after 'DPV.'
- In section 7.10, changed 'License' to 'Licensee.'
- In section 7.11, changed 'validation' to 'confirmed addresses.'
- In section 8.5, removed 'Licensed Service.'

- In Exhibit A in the heading, add 'File' before 'Layout.' Moved the DPV False Positive Header and Detail Record to the same page. Under 'Optional DPV False Positive Notification for MASS MLOCR Equipment Processes' changed 'prescribed' to 'described.'

- In Appendix A, 1.1, revised statement to reference that DirectDPV is a table/file and does not contain addresses.
- In Appendix A, 1.3, in the first and second first and second sentence, changed 'records' to 'search criteria.'
- In Appendix A, 2.2, specified 'NCOA^{Link} Full Service Providers' and removed 'users.'
- In Appendix A, 5.4, added statement that referred to Exhibit F for DirectDPV responses and descriptions.
- In Appendix A, section 6, in the last sentence of each paragraph specified that 'section c, item c (DirectDPV)' refers to PS Form 3553. In section 6.1, provided a link to the form.
