On September 30, 2017, the Postal Service will launch an online application on usps.com and Business Customer Gateway to allow consumers and commercial customers to request refunds when domestic mail is not delivered in accordance with the applicable service standards for Priority Mail Express (PME) and applicable Extra Services. Attend this webinar to learn more about the new online process for requesting refunds using either your desktop, laptop, or smart device (iOS or Android). This session will also cover the requirements and process for filing indemnity claims.

Thursday, October 5, 2017 at 11:00 a.m. EDT – Intelligent Mail Device (IMD) Full Acceptance at Non-Retail System Software (RSS) Sites

The Postal Service is enhancing the current “Full Acceptance” mail capabilities of the Intelligent Mail Device (IMD) hand-held scanner used at more than 13,000 Post Offices that do not use Retail System Software (RSS) point of service terminals. IMD “Full Acceptance” steps provide for capturing the mailpiece barcode and piece level data to include class of mail, mailing and destination ZIP Codes, postage, and Extra Service fees, for individual items. Attend this webinar to learn more about the functionality and visibility to support electronic claims and refunds processing for both customers and the Postal Service.

Tuesday, October 10, 2017 at 11:00 a.m EDT – Elimination of Four Extra Service forms

Effective October 15, 2017, the United States Postal Service will eliminate four hardcopy Extra Service forms. The four forms are:

- PS Form 3813 Insured Mail Receipt \$500 and under
- PS Form 3813-P Insured Mail Receipt Over \$500
- PS Form 3804 Return Receipt for Merchandise
- PS Form 153 Signature Confirmation Receipt

The forms are being removed from all 17,880 Retail Systems Software (RSS) sites and 1,391 RSS-BP equipped Contract Postal Unit (CPU) locations nationwide. We are leveraging the advancements of technology with the Intelligent Mail package barcode (IMpb) interface with RSS and align with the shipping industry use of black and white shipping labels that leverage the three digit service type code. Attend this session to learn more information on the elimination of four Extra Service forms and the benefits to customers and the Postal Service.
